## **Quote – Sanitization Services and Solutions**

### **Road to Race Sandton (Pty) Ltd (“RTR”)**

RTR is a level 2 BBBEE company (annexure A). The company is part of the Dueller Group of companies and has been operational since 2016. The head office is in Bryanston. Earlier this year RTR embarked on a process to market and sell a sanitizing solution for the motor vehicle trade and have since included the sanitizing of interior and exterior of infrastructure and property. In preparing the model it researched the most appropriate solution and secured a suitable chemical supplier, formulated the preferred application process and procured the required equipment.

### **Appropriate application**

Our research based on various studies (annexure B) to date concluded the absolute requirement of the continual cleaning and disinfection of common areas for public use, that could potentially cause the spread of the Corona Virus from people affected with COVID-19. Frequently touched surfaces need to be lightly wiped with a damp cloth using soap and water, followed by the disinfection using an appropriate disinfectant. The SARS-CoV-2 virus which causes COVID-19, is commonly spread through respiratory droplets which land on surfaces and can persist on these surfaces for a few days.

RTR therefore has adopted the sanitizing method whereby a fine misting process of the NRCS certified disinfectant is applied to ensure a comprehensive and even coverage of any surface area, including hard to reach spaces. This is the certainly the preferred method to the alternative fogging procedure, due to the latter only targeting air particles and not surfaces.

The active ingredient of the disinfectant, didecyl dimethyl ammonium chloride, is recommended for use against SARS-CoV-2 by the United States Environmental Protection Agency (EPA). In addition, the product has been SANS 1828:2016 certified to be safe for use on non-corrosive steel surfaces (annexure C)

Of importance is the fact that the product is child and pet friendly and will not affect the applicators applying the product.

RTR will supply the branded consumables and equipment.

### **Consumables**

The chemicals to be used and supplied by RTR contains a chemical active ingredient which will be certified as a surface disinfectant for COVID-19. In addition, RTR will exercise its best endeavours to ensure that its preferred suppliers will stock sufficient inventory in terms of the expected forecast levels given.

### **Equipment and training**

RTR will provide the necessary training manual and specification of equipment required to effectively perform the sanitising operation.

RTR will supply each operation with a tap to control the product dispensing and a measuring tool to assist with the correct product mixing.
